**Hamilton Rod & Gun Club By-Law
March 7, 2007**

ARTICLE XII-Paragraph 4: All adults who submit a new membership application after March 8, 2007 will be required to provide:

1. Ten (10) hours of labor during the first year of membership to support the club.
2. Participate in a major club function for four (4) hours determined by the BOD

OR

New members may opt out of requirement by paying an additional one-time \$100.00 fee.

AND

ALL new members must attend a minimum of three (3) general membership meetings during their 1st membership year, unless excused by B.O.D. and Membership Chair for just cause-Use new member sign-in sheet.

NOTE: Only one (1) adult member per family membership will be requested to meet the above requirements.

*By signing below the member agrees that in the event of a dispute between the member and the Hamilton Rod and Gun Club, the member agrees to limit the club's liability to the actual value of one year's cost of membership dues.

To use the 2010 – NEW MEMBERS PRICE SHEET:

1. Select the column that has the month of the General Membership Meeting where the application will be presented.
2. On the left, select the row that contains the membership type that you are applying.
3. The total cost can be found where these two lines cross. This will prorate your membership and extend or shorten the length of your membership so it will have a renewal month of March 2010 or March 2011.
4. The Initiation Fee column is included for reference; this amount has already been included in the price shown.
5. The '# of Months Covered' is the number of months before your membership will be up for renewal.

Example: If you are applying for a Family Membership in the middle of April 2009, it will be read at the next General Membership Meeting in May. Follow the May column down and the Family row across and the amount to pay will be \$174 and your membership will be for 10 months and be up for renewal in March 2011. All renewals that follow will be for a period of 12 months.
